#### REPORTS FROM ADMINISTRATION

Mayor Owens announced reports from Administration.

City Manager Doom reported that she will monitor the county website, direct our residents to that site from our website, and also our Facebook site; heard from police chief; discussion on who will have the vaccinations first; currently a limited supply and more are in the process of being made; constant monitoring in our county; the Michigan Economic Development Corporation (MEDC) has a new round of funding available for businesses; come to our FB page and information will be shared there; December 18<sup>th</sup> is the last day for yard waste pickup; we are officially closed to the public Dec. 23<sup>rd</sup> – 25<sup>th</sup>. Councilman DeMonaco asked for an update on the body cams. Assistant City Manager Fairbrother reported that IT is in the process of upgrading infrastructure to deploy body cams. Councilman DeMonaco questioned about the asphalt project if we can do a one-page update on the three streets where we put asphalt down. Director Abraham stated all have been substantially completed, however, some minor items still need to be completed. Councilman DeMonaco questioned about the purchase of fire hydrants; Councilman DeMonaco also inquired about our city buildings being salted when there was no snow. Assistant City Manager Fairbrother mentioned that he had already reached out to the contractor Xpert as there was no reason for them to have salted on Sunday.

Finance Director Blum reported that the bound audit report had finally arrived and will be distributed in council's packets on Friday; with the damage to council chambers, we had the contractor in yesterday; matched the block and bricks, which have been ordered, also the carpet has been matched and ordered; looking for wallpaper to match the current design; anticipated completion will be mid to late January to start; will be able to work throughout the winter; all carpet is getting replaced, and possibly all wallpaper if they are unable to match. Councilman DeMonaco wanted to know, since we had the rate study with AEW, where are we at with the 25 to 30% cushion in the water sewer fund as discussed when the study was completed. Finance Director Blum stated the operating cushion is pretty much nonexistent due to the lack of increases and reduction in water usage; our target was \$2.5M cushion and that's nowhere to be found; we're in the low hundred-thousands.

Attorney Albright had no report.

## A RESOLUTION calling for the Michigan Legislature to support proportional representation via ranked-choice voting

WHEREAS a strong democracy encourages public discourse and debate, which is best achieved when elected leaders accurately reflect and represent their electorate;

WHEREAS residents of local communities are best positioned to make decisions that affect their own community;

WHEREAS ranked-choice voting elections guarantee that elected officials are elected by a majority of voters, whereas plurality elections do not;

WHEREAS ranked-choice voting elections encourage more friendly campaigns, by advocating to be a second or third choice if a voter is already committed to other candidates;

WHEREAS most elections in the United States, in all levels of government in the United States, are winner-take-all, which does not create a reflective government;

WHEREAS our current voting system is largely inherited from our history as a British colony, and most of the world's former British colonies, including South Africa, Australia, and New Zealand, have abandoned winner-take-all elections in favor of proportional representation in order to strengthen their democracy and provide for equitable representation for all;

WHEREAS the vast majority of democratic nations across the world use some form of proportional representation;

WHEREAS winner-take-all elections often leave large numbers of voters with no representation or voice in government whatsoever;

WHEREAS a legacy of racial oppression and discrimination in the United States combined with winner-take-all elections have led people of color to often be on the losing side of elections, historically excluded from elected office and blocked from winning adequate representation by their elected officials;

WHEREAS, under winner-take-all elections, the primary way to increase representation by and for communities of color is to draw so-called "majority minority" districts which can only be created with severe racial segregation, and even these districts leave the interests of communities from other districts unaddressed:

WHEREAS not all of our communities live in the kinds of highly-segregated neighborhoods necessary to create majority-minority districts, yet they too deserve adequate representation;

WHEREAS in order to adequately address the issue of depressed political representation for voters of color, it is necessary to reform or re-design the elements of our electoral system that perpetuate racial inequality;

WHEREAS proportional representation for local elections reduce structural biases by increasing voter choice and eliminating the need to draw racially segregated districts in order for people of color to form a powerful voting bloc;

WHEREAS, many jurisdictions including Berkeley, San Francisco, San Leandro, and Oakland (CA); Telluride (CO); Amherst, Cambridge, Easthampton, Lowell, and Worcester (MA); Takoma Park (MD); Portland (ME); St. Louis Park, Minneapolis, and St. Paul (MN); Las Cruces and Santa Fe (NM); New York City (NY); Cincinnati and Cleveland (OH); Basalt and Benton County (OR); Payson and Vineyard (UT); and Eastpointe; either currently or in the past used proportional representation for municipal elections for councils or boards which produced politically, geographically, and racially diverse councils;

WHEREAS the residents of the City of Ferndale in 2004 passed a Charter Amendment to use instant run-off voting for municipal elections, but the election method cannot take effect until allowed by State Law;

THEREFORE BE IT RESOLVED THAT the City of Eastpointe supports passage and the implementation of proportional representation via ranked-choice voting for local elections throughout the State, at the discretion of each individual community, similar to House Bill 5282 (2019).

THEREFORE BE IT RESOLVED THAT this Resolution be sent to State Representative Hertel, State Senator Wojno, County Commissioner Klinefelt, and the Governor-appointed Black Leadership Advisory Council.

Per International Fire Code (IFC), the following heating devices are not approved for interior Tent use.

IFC:

<u>Section 603.4.2.1.1</u> Prohibited Locations. The storage or use of portable outdoor gas-fired heating appliances is prohibited in any of the following locations:

- 1. Inside of any occupancy where connected to a fuel gas container. (propane, natural gas or gasoline).
- 2. Inside of tents, canopies and membrane structures.
- 3. On exterior balconies.

<u>Section 3104.7</u> Open or exposed flame. Open flame or other devices emitting flame, fire, heat or any flammable or combustible liquids, gas, charcoal or other cooking device or any other unapproved devices shall not be permitted inside or located within 20 feet of the tent or membrane structures while open to the public unless approved by the fire code official.





The above are examples of the types of heating units that are prohibited inside of tents. This list is not all inclusive but only an example of a few prohibited gas-fired heaters.



## What is Approved?

Propane fed heaters may be used for heating tents, as long as they are <u>outside</u> of the tent and have a tube which blows the warm air into the tent keeping the heater a safe distance from the tent!

<u>Section 603.4.2.1.2</u> Clearance to buildings. Portable outdoor gas-fired heating appliances shall be located not less than 5 feet from buildings.

<u>Section 603.4.2.1.3</u> Clearance to combustible materials. Portable outdoor gas-fired heating appliances shall not be located beneath, or closer than 5 feet to combustible decorations and combustible overhangs, awnings, sunshades or similar combustible attachments to buildings.



The above are examples of the types of heating units that are approved propane heaters for exterior use for tents. This list is not all inclusive but only an example of approved heaters.

### **Electric Heaters?**

<u>Section 604.10</u> Portable, electric space heaters. Where not prohibited by other sections of this code, portable, electric space heaters shall be permitted to be used in all occupancies in accordance with Sections 604.10.1 through 604.10.5.

- 604.10.1 Listed and labeled. Only listed an label portable, electric space heaters shall be used
- 604.10.2 Power supply. Portable, electric space heaters shall be plugged directly into an approved receptacle.
- Extension cords. Use of Extension cords must be approved by a Licensed Electrician.
- 604.10.4 Prohibited areas. Portable, electric space heaters shall not be operated within 3 feet of any combustible materials. Portable, electric space heaters shall be operated only in locations for which they are listed.


