It is preferred that responses be submitted online through the MITN E-Purchasing System. However, the City will accept hardcopy proposals. Proposals must be submitted to the City Clerk Office in an envelope marked “Forcible Entry Training Door Prop”.

Offerors that do not successfully upload and/or submit all required documents by the due date and time will not be considered for award. It is recommended that offerors allow ample time to upload and/or submit documents and confirm that the submission was successful. Bid submissions will be time-stamped by the MITN E-Purchasing System upon receipt. The City is not obligated to accept proposals from offerors that fail to upload and/or submit documents on time for any reason including technical issues and/or force majeure.

Note that your electronic proposal must be successfully submitted and not just uploaded. You will receive a “Bid Submission Confirmation” pop-up window prior to final submission. If you are unsure if your documents were submitted successfully, contact MITN E-Purchasing System.

GENERAL

Bids are solicited by the City of Eastpointe for the purchase and delivery of one (1) forcible entry training door prop.

BID SPECIFICATIONS

The purpose of this document is to create minimum specifications for purchase and delivery of ONE (1) new forcible entry training door prop. Deviations from these specifications must be listed on a separate sheet of paper.

The bidder shall include a quote, which includes delivery, and delivery estimated time of delivery, of the product/system.

A written warranty must be furnished to THE CITY OF EASTPOINTE. The successful bidder must supply equipment direct from the manufacturer or from an authorized dealer available for response upon equipment failure.

In compliance with the Buy American Act (41 U.S.C. 10), THE CITY OF EASTPOINTE will give preference to domestic end products and domestic construction materials. In addition, the Memorandum of Understanding between the United States of America and the European Economic Community on Government Procurement, and the North America Free Trade Agreement (NAFTA), provide the EC and NAFTA end products and construction materials are exempted from application of The Buy American Act.

No party which is debarred or suspended or is otherwise excluded from or ineligible for participation in Federal assistance programs under Executive Order 12549, "Debarment and Suspension" will be awarded a contract with THE CITY OF EASTPOINTE. The successful bidder will not be presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any federal department or agency.

PRODUCT SPECIFICATIONS

Product must be constructed using structural steel then powder coat primed and powder coat colored using heavy duty commercial grade finishes.

Product should strive to meet NFPA 1001 JPR's for Forcible Entry

Product dimensions at outer most points no greater than 60" (5')w x 36" (3')d x 78" (6.5')h

Product weight must be less than 1000 lbs. ship weight and 950lbs net product weight.

Assembled product must include wheels for easy movement and storage and must not require dis-assembly for this process.

Product must be able to be rolled through all standard height/width commercial doorways, which measure 36" (3') or larger.

Product must include a 1-year manufacturer's warranty.

The product must include training applications for the following skill sets:

- Cut up to 3/4" rebar or other round metal material at up to 3 different heights and angles.

- Commercial hinge cutting attachment, which will allow cutting and hinge pull operations.

- Residential hinge cutting and pulling operations.

- Flat plate cutting, up to 3/8 thick

- Combination and pad lock cutting, breaking (using irons, K-12 or bolt cutters).

- Conventional forcible entry in the following applications:

 - Residential/commercial inward swinging

 - Commercial outward swinging

 - Hydraulic Forcible entry

 - "K" tool use

 - commercial lock pull simulator

 - Through the lock complete function with real commercial dead bolt latch manipulation

 - "R" tool use, residential dead bolt lock pull simulator

 - Through the lock complete function with real residential dead bolt latch manipulation

 - Commercial door metal plunge cut window with real working panic bar to activate and open.
